



**Parental Consent**

**For competitors under 18, a parent or guardian must sign**

**WARNING: This is a legal document that affects your rights please read carefully before signing.**

On behalf of the child/ward listed above, I, as the parent and/or guardian agree for them to compete in this event on the following basis:

1. I acknowledge that competitive triathlon involves the real risk of serious injury or even death from various causes including overexertion, equipment failure, dehydration, accidents with other competitors, spectators or road users, and course or weather conditions to name a few.
2. I understand that my child/ward should not compete in this event unless they have trained appropriately and a medical practitioner has verified their physical condition.
3. By my child/ward competing, I accept all risks necessarily flowing from their participation that could result in loss of life or permanent injury. Accordingly, I release all persons or corporations associated directly or indirectly with the conduct of the event from all claims demands and proceedings arising out of my child/ward's participation and I hereby indemnify them against all liability (including liability for their negligence and the negligence of others) for all injury, loss or damage arising out of or connected with my child/ward's participation in this event. This release shall extend to and include In 2 Adventure, Triathlon Australia Limited, its members state and territory triathlon associations and all of their respective directors, partners, managers, officers, employees, agents, contractors and volunteers including medical and paramedical personnel appointed for the event, the owners, licensees and occupiers of land upon which the event or any part of it is conducted, any statutory body or local authority having control over any land upon which the event or any part of it is conducted or which is involved directly or indirectly with the event in any manner whatsoever and promoters, sponsors and event organisers. This release and indemnity continues forever and binds my and my child/ward's heirs, executors, personal representatives and assigns.
4. I consent to my child/ward receiving any medical treatment including ambulance transportation that event organisers think desirable during or after the event.
5. I consent to event organisers using my child/ward's name, image and likeness, before, during or after the event, for event promotional broadcasting or reporting purposes in any media.
6. I understand that the information that I have provided herein will be included in a Triathlon Australia database and may be disclosed on occasions to the Australian Institute of Sports Commission, State Institutes and Academy of Sport and the Australian Sports Drug Agency. I also understand that information of a biographical nature including my child/ward's name, date of birth, home state, results, career highlights and interests may be released to the media in response to general requests.
7. I understand that compulsory insurance cover affected for participants in this event may not cover my child/ward for any or all injury, loss or damage sustained by them.
8. Safety precautions undertaken by organisers (such as course supervision, race safety briefings, bicycle and helmet safety checks) are a service to my child/ward and other competitors but are not a guarantee of safety.
9. I am fully responsible for the security of my child/ward's personal possessions at the event.
10. My child/ward's registration is not transferable to other people. If they are unable to compete I agree to the terms and conditions of In 2 Adventure's refund policy and transfer policy listed on [www.tre-x.com.au](http://www.tre-x.com.au). If the event is cancelled, my registration fee is non-refundable.
11. I have listed on the entry details of any medical or physical conditions from which my child/ward suffers that might affect their performance or be relevant if medical treatment is needed. I accept the risk of my child/ward competing despite these conditions.
12. I agree that I will ensure that my child/ward abides by all race rules and directions issued by Triathlon Australia and the event organiser.
13. Event Organisers may change the event format, course or other race conditions at their discretion. If that occurs this agreement applies to the changed conditions.
14. I agree that if my child/ward fails to return the timing band in good condition to the race organisers at completion of the event that I will incur a \$50 charge as the replacement cost.
